### Request for funds for Food Parcels: COVID-19 Lockdown period

During this time of distress due to the declared 21 days lockdown in South Africa, Ndlovu Care Group(NCG) is in need of funds to distribute food parcels to our Child Care Programmes beneficiaries.

I am writing to request donation to buy food parcels for our beneficiaries whom their good health and livelihood rely on daily nutritious meals offered and NCG Child Care centres.

This groups involve the following in order of priority:

#### 1. Ndlovu Nutritional Units( NNUs)

NNUs aim to prevent and treat malnutrition of children and improve their nutritional situation through education of the mother/caregiver and change in the home situation. After being identified disabled children are registered in our centres and we offer 2 nutritious meals per day at the while they are at the centres.

Currently Ndlovu Nutritional Units have 94 beneficiaries allocated as follows:

The Ndlovu pre-schools apply government approved early Childhood Development approach, which is an innovative and inspiring approach to early childhood education. Number of Beneficiaries in the ECD centres are:

All the 383 direct beneficiaries have a potential to relapse during the temporary closure of the Ndlovu Centres. Thus, we have planned to supply them with food parcels during the first 21 days of lockdown, which will be delivered to individual households by the NCG staff. Fund permitting we would like to expand the food supply to the indirect beneficiaries, viz. older sibling. Since the closure of the schools, it will mean they also cannot benefit on the one(1) nutritious meal that they get through school-feeding scheme. Thus, the whole family will go hungry.
